### **Terms and Conditions for Quiz, Lucky Draw and Grand Draw**

The below terms and conditions are applicable for participation in the Quiz, Lucky Draw and Grand Draw conducted at the Barco Future-Ready Workplace Virtual Conference (hereinafter referred to as “Virtual Conference”).

#### **How to Enter:**

Please follow the instructions as explained by the event host for participation during the conference for Quiz, Lucky Draw and Grand Draw.

#### **Eligibility:**

1. The participant must be a registrant for the Virtual Conference and resides in Asia Pacific (excluding China and Hong Kong).
2. The participant must enter his or her Full Name, Work Email, Contact Number and Full Address (including City and Postal Code) at event registration and must indicate that he or she authorizes Barco and event partners to contact them for communication and event notifications.
3. The Quiz, Lucky Draw and Grand Draw are opened to all event delegates of the Virtual Conference and must not be by proxy. Employees of Barco and event partners and event agency are not eligible to participate.
