Full Terms and Conditions

By entering this promotion (herein "Promotion"), all participants or entrants agree to abide by these terms and conditions and any decision the Promoter makes regarding this Promotion, which the Promoter shall make in its sole discretion.

- This Promotion is open to end users, or a partner company who is a reseller or an integrator, either attending InfoComm 2018 in Las Vegas, NV or any time during the Promotion period. Distributors, Barco employees, and its parent and 3rd party agencies affiliated with this Promotion are not eligible to enter to win.
- Available only to residents in the US, Canada, and Latin American countries.
- All entrants must be 18 years of age or over in the jurisdiction of residence.
